Dear Brothers and Sisters,

COTA WAGE NEGOTIATIONS 2014/16

Prior to this year's negotiations commencing our joint Shop Stewards brought forward members aspirations for this year's review including an above inflation increase on the basic rates of pay.

COTA on the 1st May 2014 presented us with written confirmation of their final offer which is a two year deal and is made up as follows:

In the first year of the deal 2014-15

Increase the Base Salary by	3.0%
Introduce a payment of £40 to be made in the event of an employee being delayed on the unit by 6 hours or more beyond flight departure time. This payment to be made on no more than one occasion per offshore cycle.	0.37%
Increase all bands of the Travel Allowance by £5.	0.18%
Total for year one.	3.55%

In the second year of the deal 2015-16

Increase the Base Salary by RPI in June 2015 plus 0.8%	RPI + 0.8%
Increase the offshore delay payment introduced in 2014 from £40 per delay to £75	0.32%
Introduce a minimum payment for those who undertake training for emergency duties out with their normal working hours - 3 hours at overtime rate.	0.12%
Amend Clause 27 of the Agreement so that the Shetland Payment would now be made in the event of all delays enroute between the unit and the point of departure.	0.05%
Total value of year two	RPI + 1.29%

Shop Stewards and many members wished us to address the growing salary gap between the COTA grades. The negotiating committee submitted as part of the claim a request that the same monetary value be used as an increase on all grades, however COTA rejected this offer at the first meeting.

Throughout the negotiations 2nd and 22nd April 2014 our negotiating committee have tried to secure an offer that would be acceptable to our members and for this reason the **Negotiating Committee have recommend you ACCEPT the offer.**

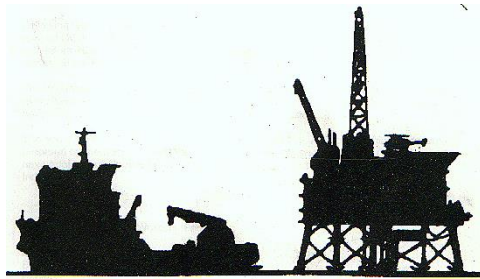
